FROM NORTHERN BERGEN COUNTY

FOLLOW THE GARDEN STATE PARKWAY DIRECTIONS

FOR THOSE ACCESSIBLE TO ROUTE 4

TAKE ROUTE 4 EAST. EXIT AT GRAND AVENUE (LEONIA). THEN MAKE RIGHT TURN ONTO GRAND AVENUE SOUTH (WE ARE THE 3RD BUILDING ON THE RIGHT ONLY 200 YARDS SOUTH OF ROUTE 4 ON THE WEST SIDE OF THE STREET NEXT TO SONNY'S PIZZERIA.

FROM THE GARDEN STATE PARKWAY

EXIT THE GARDEN STATE PARKWAY AT EXIT 159-SADDLE BROOK. PROCEED TO ROUTE 80 EAST. STAY IN THE LOCAL LANES AND PROCEED TO EXIT 71 AND TAKE THE BROAD AVENUE/ENGLEWOOD EXIT, BEARING RIGHT ONTO BROAD AVENUE. AT THE 1ST TRAFFIC LIGHT, TURN LEFT ONTO SHEFFIELD AVENUE. CONTINUE TO THE NEXT LIGHT, AND TURN RIGHT ONTO GRAND AVENUE. OUR BUILDING IS ON THE LEFT, IMMEDIATELY AFTER SONNY'S PIZZERIA.

FROM ROCKLAND COUNTY AND EASTERN BERGEN COUNTY

TAKE THE PALISADES PARKWAY SOUTH TO EXIT 1 – PALISADES AVENUE. TURN RIGHT AT THE BOTTOM OF THE EXIT RAMP AND GO DOWN PALISADE AVENUE APPROXIMATELY 2 MILES AND MAKE A LEFT ONTO DANA PLACE WHICH BECOMES BROAD AVENUE. CONTINUE APPROXIMATELY ONE MILE FURTHER, AND TURN RIGHT AT THE 2ND LIGHT ONTO SHEFFIELD AVENUE. OUR BUILDING IS ON THE LEFT, IMMEDIATELY AFTER SONNY'S PIZZERIA.

FROM THE NEW JERSEY TURNPIKE

TAKE THE NEW JERSEY TURNPIKE NORTH (STAY IN THE LOCAL LANES) TO EXIT 71 – BROAD AVENUE/ENGLEWOOD, BEARING RIGHT ONTO BROAD AVENUE. AT THE 1ST TRAFFIC LIGHT, TURN LEFT ONTO SHEFFIELD AVENUE. CONTINUE TO THE NEXT LIGHT AND TURN RIGHT ONTO GRAND AVENUE. OUR BUILDING IS ON THE LEFT, IMMEDIATELY AFTER SONNY'S PIZZERIA.

FROM ROUTE 80 EAST

STAY IN 80 EAST LOCAL LANES AND TAKE EXIT 71 - THE BROAD AVENUE/ENGLEWOOD EXIT, BEARING RIGHT ONTO BROAD AVENUE. AT THE 1ST TRAFFIC LIGHT, TURN LEFT ONTO SHEFFIELD AVENUE. CONTINUE TO THE NEXT LIGHT, AND TURN RIGHT ONTO GRAND AVENUE. OUR BUILDING IN ON THE LEFT, IMMEDIATELY AFTER SONNY'S PIZZERIA.

FOR THOSE COMING FROM HUDSON COUNTY – NORTH BERGEN , UNION CITY, WEST NEW YORK AND JERSEY CITY AREAS:

GET ONTO THE NEW JERSEY TURNPIKE NORTH AND FOLLOW TURNPIKE DIRECTIONS

OR

TAKE TONNELE AVENUE NORTH

WHEN YOU GET TO 90TH STREET IN THE TOWN OF FAIRVIEW – TONNELE AVENUE BECOMES BROAD AVENUE.

CONTINUE FOR APPROXIMATELY ONE MILE UNTIL YOU GET TO THE TOWN OF RIDGEFIELD – THEN YOU WILL COME TO A FORK AT A TRAFFIC LIGHT. BEAR LEFT AT THE FORK WHICH IS THE BEGINNING OF GRAND AVENUE. TRAVEL NORTH ON GRAND AVENUE (APPROXIMATELY 4 MILES OR 8 LIGHTS).

PATIENT CARE ASSOCIATES AT 500 GRAND AVENUE WILL BE ON YOUR LEFT NEXT TO SONNY'S PIZZERIA (ONLY 150 YARDS SOUTH OF THE ROUTE 4 HIGHWAY).

FROM NEW YORK CITY

AFTER CROSSING OVER THE GEORGE WASHINGTON BRIDGE, TAKE ROUTE 4 WEST FOR APPROXIMATELY 1.1 MILES EXITING ONTO GRAND AVENUE SOUTH TOWARDS LEONIA. WE ARE THE 3RD BUILDING ON THE RIGHT AFTER YOU PASS UNDER ROUTE 4.
